## **Director's Report**

- A. Financial Update- Kathy Horath reports healthy fund balance. MPSED is waiting for bill from DPS for new office windows. Invoice will be paid from last year's budget to align with board approval. Final Bills will go out soon, any credits will be applied to October bill. 25-26 Final budget approval scheduled for 8/19/25. SELA daily rate has been established at \$127.97.
- B. First Read- Board Policies Section 6 (6:10, 6:20, 6:30, 6:40, 6:60, 6:65, 6:70, 6:80, 6:100, 6:110, 6:120, 6:210, 6:235, 6:240, 6:250, 6:255, 6:260, 6:270, 6:280, 6:290, 6:300, 6:340)- Kathy sent electronically for Board members to view and asked to report anything outstanding.
- C. First Read- Board Policies Section 7 (7:10, 7:15, 7:20, 7:30, 7:80, 7:90, 7:130, 7:140, 7:150, 7:160, 7:170, 7:180, 7:185, 7:190, 7:200, 7:210, 7:220, 7:230, 7:250, 7:255, 7:270, 7:275, 7:280, 7:285, 7:290, 7:340, 7:345)- Kathy sent electronically for Board members to view and asked to report anything outstanding. Noted that diplomas will come from home districts as well as suspension and expulsion determinations.
- D. HB 2390 and the Joint Agreement- Governor has not yet signed, but if approved MPSED Board will have to re-write agreement. Biggest change being any member districts wanting to withdraw from the Cooperative will have to submit the request 18 months in advance instead of current 12 months.
- E. Possible Therapeutic Day Option for the area- MPSED was approached by Little Friends, Inc. looking to grow a facility in our area, but no current leads on available buildings. Little Friends, Inc. services students with autism or developmental disabilities. Board agrees that there is a need in the area but concerned that we would potentially lose staff.
- F. Vacancy Update- A lot of TA vacancies. Subs lined up to fill teaching vacancies.

- G. Director of Special Education posting- Job posting to go live 8/8/25. Posting locally as well as out to IHSA, and IAASE.
- H. Program Update- DPS cut Extended Day at SELA. MPSED has worked out an option to continue the service internally using funds that are already budgeted. 7 students entering Kindergarten from —Pershing are not-deemed for full day-instruction and will start ½ days. SDMS will move from 1 SED classroom to 2 SED classrooms this year.
- I. Due Process/ISBE Complaint Update- None open currently pertaining to students with an IEP.

Hearing no further questions or topics to discuss, Chairman Jones entertained a motion to adjourn.
